- \_\_\_\_\_ 1. **DOMESTIC MAIDEN** - A negative uterine culture is required to be taken 60 days prior to the initial cover in 2009 and if returning for a third heat.  
**ALL MAIDEN MARES MUST BE JUMPED BEFORE ARRIVAL AT THE BREEDING SHED.**
- \_\_\_\_\_ 2. **DOMESTIC BARREN** – A negative uterine culture is required to be taken 60 days prior to the initial cover in 2009 and if returning for a third heat.
- \_\_\_\_\_ 3. **DOMESTIC FOALING** – A negative uterine culture is required if returning for a third heat.
- \_\_\_\_\_ 4. **IMPORTED MAIDEN** – All mares must have a negative pre-breeding C.F. Test. Obtain a culture from the clitoral fossa and sinuses. A second set of cultures should be obtained seven to fourteen days after the first set. One of these sets of cultures shall be obtained while the mare is in early estrus, at which time the endometrium of the uterus shall be cultured.
- \_\_\_\_\_ 5. **IMPORTED BARREN & FOALING MARES** – Contact the State Veterinarian's Office in Frankfort, KY regarding testing procedures and acquisition of quarantine release for the 2009 breeding season.  
**A copy of the quarantine release must accompany the mare on her first trip to the breeding shed.**
- \_\_\_\_\_ 6. **RETURN COVERS** – A negative uterine culture is required if returning for a third heat. Proof of this culture must accompany the mare to the breeding shed.
- \_\_\_\_\_ 7. **DOUBLE**
